A complaint against the Temporary Ranking List may be filed within 36 hours of the announcement of the Temporary Ranking List, until Monday, October 11, 2021, by 12:00 p.m.

A complaint shall be submitted to the Enrollment Commission through Office for postgraduate studies.

Enrollment Commission makes a decision on the complaint within 24 hours of receiving the complaint.

After deciding on the complaint, the Faculty determines and announces the final Ranking list for enrollment in the master academic studies - Master in European Integration.
