## INFORMATION RELATED TO THE ENROLLMENT AT MASTER IN EUROPEAN INTEGRATION FOR THE ACADEMIC YEAR 2022/23

We hereby inform students who submitted the application for the enrollment to Master in European Integration for the academic year 2022/2023, that the enrollment shall be conducted **from Wednesday, 12th October to Monday, 17th October 2022**, according to the following schedule:

- on 12th October from 10.00 to 14.30 h,
- on 13th October from 10.00 to 17.00 h,
- on 14th October from 10.00 to 14.30 h,
- on 17th October from 10.00 to 14.30 h.

For the enrolment procedure the following documents shall be submitted:

- 1) Index (student's booklet) with first page filled in block letters and with photograph size 35x45 mm (not from the photo automat); **do not stick foil** attached to the index;
- 2) One enrollment form - ŠV-20 form – available at: <https://publikacije.stat.gov.rs/G2022/Pdf/G202224061.pdf>. On a single copy in the upper right corner attach the photo size 35x45 mm (not from the photo automat)
- 3) Proof of payment of the first installment of the tuition fee to the Faculty of Law bank account number 840-1439666-55, reference number (poziv na broj): 540
  - Citizens of the Republic of Serbia and the Republic of Srpska – 37.500,00 RSD;
  - Foreign citizens – 525 € in RSD counter value according to the middle currency of National Bank of Serbia on the day of payment.

Candidates who are re-enrolling (with recognized attended lectures and passed exams) will pay the fee in accordance with number of remaining ECTS (1 ECTS = 1.000,00 RSD for citizens of the Republic of Serbia and the Republic of Srpska and 22 EUR in RSD counter-value according to the middle currency of National Bank of Serbia on the day of payment for foreign citizens - *Practical Skills* – 3 ECTS, *Introduction to the Legal System of the EU* – 5 ECTS, *Introduction to the Political System of the EU* – 5 ECTS, *Introduction to the Economic System of the EU* – 5 ECTS, optional courses (in total three) each 8 ECTS, Master's Thesis – 18 ECTS.

Deadlines for payments of remaining three installments are: second installment: 20.12.2022; third installment: 20.2.2023; fourth installment: 20.4.2023.

- 4) Proof of payment of the amount of **100, 00 RSD** for the Center for Carrier Development of Belgrade University, to the Faculty of Law bank account number **840-1439666-55**, reference number (poziv na broj): 540 (to be paid also by students financed from the budget).

Index can be bought in the Faculty bookstore (working hours until 15.00).

**Notes:**

The enrollment of candidates, who are in the process of recognition of foreign university diplomas for purposes of further education, will be conducted upon the delivery of positive decision of the University of Belgrade.

Candidates who did not complete Bachelor academic studies at the University of Belgrade Faculty of Law and who submitted certificate on graduation with transcript of records because issuing of diploma is in progress, have an obligation to submit certified copies of diploma and diploma supplement within a year.

After enrollment, all students must activate e-student account using new index number and fill out electronic ŠV form or they would not be able to apply for exams.

**IMPORTANT NOTICE FOR STUDENTS ENROLLED IN THE ACADEMIC YEAR 2019/2020, WHO HAD LAST ACTIVE STATUS IN THE ACADEMIC YEAR 2021/2022 AND WHO HAVE ONLY MASTER'S THESIS LEFT UNTIL COMPLETION OF STUDIES**

In accordance with recommendations of the Ministry of Education, Science and Technological development and with regard to circumstances caused by epidemic of contagious disease *COVID-19*, students of Master academic studies who had last active status in the academic year 2021/2022 and who have only Master's thesis left until completion of studies, upon personal request, will have extension of deadline for completion of studies for another year.

Students who applied for re-enrollment (see the table) and paid the application fee in amount of 3.500,00 RSD will have this amount at disposal at e-student account.
